FROZEN SEMEN CONTRACT FOR 2017 BREEDING SEASON

CALYPSO OS

The breeding season and semen shipments start on February 1 and end on August 31.

The breeding fee is 2,500.00 EUR (plus applicable bank wire fees) to be paid to Ottoman Arabians (see end of this contract for bank wiring details). This breeding fee is non-refundable and must be paid in full before semen is shipped. Mare Owner acknowledges this breeding and all of its doses must be used during 2017 breeding season and are non-transferable, meaning that breedings purchased under this agreement cannot be re-sold or provided to any other party without receiving express written permission from Ottoman Arabians to do so. Breeding reports will not be issued until all costs described below are paid in full.

Semen is distributed by Osterhof Stud. Mare Owner agrees to pay Osterhof Stud for the following handling fees before receiving first semen shipment:

1.	Flat fee handling rate for each delivery of frozen semen within the EU. (Each shipment will contain enough semen for two cycles.)	125.00 EUR
2.	A health certificate for frozen semen shipments within the EU.	125.00 EUR
3.	19% tax	28.50 EUR
	Total:	278.50 EUR
4.	Shipping costs vary depending upon transportation company rates, parcel weight, and distance to destination.	Varies

It is guaranteed that only semen from CALYPSO OS will be shipped. Ottoman Arabians shall provide semen from CALYPSO OS, the stallion identified in this contract, and makes no other guarantees regarding the condition of the semen once it has left Osterhof Stud. Mare Owner shall be responsible for the proper storage, handling, and insemination of the semen into mare (note thawing temp for Botu-Crio extender is 20 seconds at 47°C, not 30 seconds at 36°C!).

Unless another arrangement has been made in advance, Mare Owner agrees to return shipping container to Osterhof Stud within two business days of receiving semen shipment (via 3-day air or ground delivery). Mare Owner is responsible for organizing and paying for this return. Mare Owner or veterinarian agrees to fill out enclosed semen report correctly, legibly, and as soon as possible, and return to Osterhof Stud.

Ottoman Arabians guarantees CALYPSO OS has tested negative for Cerebellar Abiotrophy (CA), Lavender Foal Syndrome (LFS), and Severe Combined Immunodeficiency (SCID). Mare Owner agrees and acknowledges, however, that Ottoman Arabians does not make any warranty as to the quality or conformation of the foal or that the foal will be free of any infirmity, conformation defect, disease or inherited trait. Should mare fail to conceive, die, or not produce a live foal for a period of at least 24 hours from the time of birth, Mare Owner has the right to rebreed said mare (or substitute mare upon written approval of Ottoman Arabians) in subsequent breeding season (2018) and pay all necessary shipping/handling fees to Osterhof Stud. If this rebreeding is unsuccessful, Mare Owner has option to attempt one last rebreed in subsequent breeding season (2019) by paying all necessary shipping/handling fees plus an additional 50% of original breeding fee (2,500 EUR x 50% = 1,250 EUR) to Ottoman Arabians (plus applicable bank fees). Should mare fail to conceive from this second rebreed, Mare Owner forfeits right to breed under this contract.
